Tall Pines is a pet-friendly property. We have pet guidelines. As per the rules and regulations, breed restrictions are as follows--No Pit-bulls, Pit-bull mix breeds, Dobermans, Rottweilers or Chows permitted. Pets must be kept on a 6 ft leash at all times. **Extension leashes are not permitted.**

## TALL PINES PET RULES Updated: 04/11/19

- 1. Pets must be confined inside the RV unless being exercised, during which time they must be kept on a leash. No pets can be tied out or in an outdoor kennel. You must be with your pet while it is outdoors.
- 2. <u>Leashing</u>: Please be aware of the Delaware leash law that requires all pets to be leashed while at our campground, this is even if you do not use a leash at home. 6' leash only, NO extension leashes permitted.
- 3. <u>Pet waste</u>: Please pick up after your pet. Residents are required to have pet waste disposal bags with them while walking their pet. Anyone found walking their pet without a pet waste disposal bag will be considered in violation of our pet rules.
- 4. <u>Public areas</u>: Pets are not permitted in the public areas to include, bath houses, recreation areas, including the pool, pavilion, volleyball, horseshoe areas, camp store, fitness room, mini golf and playground.
- 5. <u>Breed Restriction</u>: Pit Bulls, Pit Bull Mix Breeds, American Staffordshire Terrier, American Pit Bull Terrier, Dobermans, Rottweiler's and Chows are not permitted as pets in Tall Pines. If a Licensee brings one of these restricted breeds into the Tall Pines community to replace a pet or as another added pet, the Licensee will be immediately instructed to remove all restricted pets from their property and face probable termination of their License Agreement.
- 6. <u>Dogs must be licensed</u>. This is required by the State of Delaware. Violators face a fine of \$50 to \$100 for the first offense. Your animal must wear the license tag on their collar or leash at all times.
- 7. <u>Pet registration:</u> You are required to register your pet at the Tall Pines office. This will include a certificate of license, proof of current rabies and distemper shots and a picture of your pet. Effective with the 2011 camping season, upon registration you will be given a pet ID tag to place on the pet's collar.
- 8. <u>Cats</u>: Residents who have cats must keep these animals inside their RV's, or on a leash when outside. Cats cannot be left to run loose at any time. Any resident found allowing their cat to run loose will be asked to remove the cat from the Tall Pines Community.
- 9. <u>Stray cats:</u> The feeding of stray cats is strictly prohibited. This causes the animal to stay in the community, breed, and also results in health and safety problems. Stray cats carry diseases and any resident found feeding these strays will be turned over to the Department of health.
- 10. Curbing of pets: Curbing of pets is not permitted in the playground, pool, recreation areas or pavilion.

The only pets that are permitted are: Dogs, cats, and domestic birds that are in cages. No exotic/wild pets or farm animals of any kind will be permitted. For the breed restriction change placed in 2009, IT MUST ALREADY BE REGISTERED IN OUR MANAGEMENT OFFICE to qualify to be grandfathered.

Should any pet become a nuisance, its immediate removal will be required. No fences or doghouses are permitted. If any pet is found loose it will be turned over to the S.P.C.A. Any pet that bites and/or attacks another person; or person's pet or damages public or private property will be removed from the Tall Pines property immediately and for the safety of our residents will not be permitted back in the community.
